When a student or class needs to be quarantined in response to COVID concerns, those individuals will recieve learning packets and supplemental materials from their homeroom teacher. In addition, students will utilize I-Ready (online resources) for remediation during their absences. We will be continuing this model in all forms for the 23/24 SY and will continue to adhere to CDC guidelines and recommendations.

We now have morning meetings from 8:00-8:10 in all our homeroom classes. This has made an impact with regards to having conversations with students about the upcoming days events/schedule along with hearing from the students and guaging how they are feeling and set tone/expectations for the day.
